

# ADVANCED HRV CONTROL REBATE

## Contractor guide

Select advanced HRV controls **installed by a contractor** are eligible for an instant rebate of up to \$150.

### HOW IT WORKS:

#### 1. INSTALL AN ADVANCED HRV CONTROL

Install a compatible and eligible advanced HRV control. The eligible products list can be found by visiting [efficiencyMB.ca/hrvcontrols](http://efficiencyMB.ca/hrvcontrols).

#### 2. COMPLETE THE APPLICATION AND COMPLETION FORMS

Complete the rebate application and have the customer fill out the completion declaration.

#### 3. SUBTRACT UP TO \$150 FROM THE INVOICE

When you're writing the customer's invoice, discount the **after-tax total** by up to \$150. This must be a separate line item titled "Efficiency Manitoba Rebate".

Be sure to note the manufacturer and part number of the advanced HRV control on the invoice. Use the sample invoice below as a reference.


#### 4. SUBMIT YOUR PAPERWORK

# ADVANCED HRV CONTROL REBATE

## Frequently asked questions

### Q: WHAT ARE THE BENEFITS OF AN ADVANCED HRV CONTROL?

A: An advanced HRV control can increase the efficiency of a home's HRV by better matching your customer's home ventilation needs to their lifestyle.

### Q: WHAT IS A BASIC HRV CONTROL?

A: A basic HRV control only has a manual on/off switch or timer.

### Q: WHAT IS AN ADVANCED HRV CONTROL?

A: An advanced HRV control has standby or intermittent ventilation modes and an adjustable automatic dehumidistat function that can operate in standby mode. The control must be listed on our eligible products list to be eligible for the rebate.

### Q: WHO IS ELIGIBLE FOR THE REBATE?

A: In order to be eligible for the rebate, the customer must own the home where the new control is being installed and the home must be their primary residence. This includes:

- customers who already have an HRV and want to upgrade to an advanced control; and
- customers who are installing an HRV for the first time and want an advanced control instead of a basic control.

### Q: ARE NEW HOMES ELIGIBLE?

A: Yes! Homebuilders who are installing an HRV for the first time and want an advanced control instead of a basic control are eligible. When you're filling out the application, use the builder's company name in the customer name field once the builder has the Manitoba Hydro account in their name.

### Q: ARE ADDITIONAL WIRING OR OTHER COSTS COVERED THROUGH THE PROGRAM?

A: No. The maximum rebate is \$150 per control for the product price and labor to install it. Additional costs are to be covered by the customer.

### Q: CAN A CUSTOMER PURCHASE THE ADVANCED HRV CONTROL THROUGH A CONTRACTOR AND THEN INSTALL IT THEMSELVES?

A: No. The program was designed to require certified contractors to install the HRV controls. Having a contractor install the device and program it correctly ensures the program generates enough energy savings. For this reason, only customers who have an advanced HRV control installed by a registered Efficiency Manitoba supplier will be eligible for the rebate. Homeowners who install qualifying devices on their own aren't eligible for the rebate.
